

## INSTRUCTIONS FOR COMPLETING HEALTH FORMS 2020-2021

Our school is subject to inspection by the Health Department and if parents and/or students are participating in our program without these forms, CPI would be closed immediately. If health forms are not **RECEIVED** by the Health and Safety Director before the due dates listed below, your child's enrollment may be forfeited and a child from the waitlist could be selected to fill that spot. This policy will be strictly enforced as it has become a severe compliance issue. It is advised that forms be carefully read and filled out as any incomplete form must be returned and this creates a delay in processing and could jeopardize your child's spot.

Please note: The Virginia Health Department will no longer be providing this form (MCH 213 G revised 03/2014) to private or preschools. Parents can print it from the following website. If you do not have access to a computer, please contact the Health and Safety Director and arrangements will be made to get a copy to you.

Part I - Parent must complete in its entirety; provide an emergency contact AND a parent signature is required.

Part II - Physician must complete for all immunizations and SIGN. All immunizations must be up-to-date.

Part III - Physician must complete and sign based on your child's physical exam.

Physical exams must be current within one year from your child's first day of school - any time after September 3, 2018

ALL FORMS MUST BE ORIGINAL- NO COPIES WILL BE ACCEPTED.

Note that two emergency contacts must be listed with complete, full addresses, and both parent/guardians must sign. This form is double-sided; please turn it over and complete both sides and SIGN at the bottom.

**PARENT MEDICAL FORM** - For Co-oping Parents - Required of any adult who will work in a CPI classroom. https://tinyurl.com/cpi-parentmed DUE: July 15, 2020

**Part I** – Statement of Health. All co-oping parents must attest to the fact that they are healthy enough to work with small children and have no communicable diseases. If you are unsure, please see a physician and receive a clean review of health prior to the start of school.

**Part II -** TB TEST (PPD Screening or QuantiFERON blood test) or VERBAL SCREENING QUESTIONNAIRE or CHEST X-RAY. TB skin tests (PPD Screening) are administered one day with a return visit to the doctor required several days later to read the results. Please note that skin tests are no longer offered by the health department due to a high rate of false positives; blood tests are preferred if testing is needed. Screening questionnaires are recommended for low-risk individuals. TB tests/questionnaires are only required every 2 years from administration date. Returning parents who were tested last year (after June 1, 2018) do not need to be retested, <u>but still complete Part I</u>. Chest x-rays are valid for 3 years. Sources for a TB test (PPD screening or blood test) or questionnaire include your physician, some local pharmacies or the county health department.

\*\*\* Please alert the Health & Safety Director if any <u>allergies to food</u> are present in your child. Additional forms (on our website under ENROLLMENT – Forms & Policies) MUST be completed prior to your child beginning school.
