## Items voted on during the July 2020 Special meeting:

- Fall 2020 offerings to include three core classes and enrichment classes dependent on enrollment PASS (unanimous)
- Tuition PASS (unanimous)
  - \$190/month core package (virtual + outdoor), \$85 core supply fee
  - \$150/month virtual-only core, \$85 core supply fee
  - o \$50/month virtual enrichment, \$40 enrichment supply fee
    - For virtual enrichment only, siblings can participate together by registering a single child and sharing supplies
  - o \$50 virtual club
- Extension of withdrawal deadline to Monday August 17<sup>th</sup> PASS (unanimous)
- Suspension of maintenance/cleaning party obligation for Fall 2020 term PASS (unanimous)
- Suspension of parent co-op in classrooms PASS (unanimous)
- Approval of June 2020 Meeting Minutes PASS (unanimous)

## The meeting was called to order at 7:03 PM.

- Class offerings
  - Three basic packages: 2s/3s, 4s, PreK
    - 4s & PreK
      - One 2-hour outdoor class / week
        - Up to 12 students per class, no students mixing from other inperson classes
        - Playground time, activities on porch, art craft project, read aloud
        - Hula hoop for belongings
        - Staff will wear masks and want students to wear them too. Staff will help students adjust to wearing masks.
        - Classes will occur in light rain, may try to reschedule classes canceled for thunderstorms
      - Three 1-hour virtual classes / week
        - At-home extension activities and supply kit distributed monthly for more interactive virtual activities
    - 2s & 3s
      - One 2-hour outdoor class / week
      - Two virtual classes / week (30 min 1 hour)
        - More hands-on activities and sharing time, less emphasis on math/language arts
        - o Read aloud videos, at-home extension activities

## **Centreville Preschool Board of Directors Special Meeting Minutes**

Wednesday, July 29, 2020

Virtual via Zoom

- 2s/3s virtual may be separate or combined depending on enrollment
- One 15-min one-on-one virtual chat with teacher
- $\circ$  Add-ons
  - Virtual enrichment classes
    - STEAM, creative kids, culinary kids, book club
      - Classes offered are dependent on enrollment (most need at least 4 students)
    - One 1-hour virtual class / week
  - Virtual social club
    - One virtual class / week (30-40 min)
    - Small group capped at 6 students
    - Rotating topics for discussion
- Member feedback
  - Parent suggested a personal risk level survey for families
    - Families will sign COVID-19 agreements to follow CDC guidelines in life outside of school and to keep children home if anyone in household has shown any symptoms
    - Drop-off will likely include temperature check and questionnaire
  - Parent suggested an outdoor meetup for families of each core class before classes begin
    - Virtual orientation will be held in place of open house
    - Room Parent could organize additional communication between parents within a core class
  - Parent expressed concern about limited opportunity for in-person interaction at child's developmental stage
    - Teacher Director indicated that within Virginia Cooperative Preschool Council (VCPC), there are not any co-op preschools opening for in-school classes in September
  - Multiple parents provided positive feedback that virtual summer camp went really well and was very well organized
  - Parent emphasized the importance of the outdoor class to allow a young child to adjust to separating from parent
  - Parent asked about class times and scheduling around FCPS virtual schedule
    - CPI classes cannot be scheduled around all FCPS schedules which vary by school
    - CPI classes will not overlap with each other (at least not classes in which a student might co-enroll)
    - Discussed possibility that classes may be small enough that CPI could reach out to parents to find times that work best
  - Parent asked about developmentally appropriate virtual activities for 2s/3s
    - Incorporate music and movement every 5-10 min
    - Simple interactive activities like play dough
- Tuition & Fees
  - Reached consensus on \$190/mo for core class packages, which is roughly equivalent to 75% of typical 3-day/week tuition
    - \$85 core supply fee (same amount as typical 3-day/week class)
      - Families expected to provide common supplies (e.g. crayons) at home



## Centreville Preschool Board of Directors Special Meeting Minutes

- Teacher Director will request donations of plastic bags, glue sticks, etc.
- Reached consensus on \$150/mo for core class virtual only option
  - Discussed suggestion to price at the same tuition as package but with no committee obligation
- Enrichment: \$50/mo
  - Siblings can both participate on one device by just signing up one child
- o Club: \$50/mo
  - Smaller class size and shorter duration
- CPI may not be the cheapest virtual option because we have a school building to pay for, but CPI can offer advantages of being part of a local school community (picture day, holiday theme original works, etc.)
  - Several parents agreed the tuition discussed is reasonably priced
- May 2021 deposits will be adjusted based on tuition rate for the classes a student is enrolled in for September
  - Could provide option to apply balance toward fall tuition, get a refund, or donate balance
- No monthly buy-out option offered in Fall 2020
  - \$100 flat fee will be assessed if family does not fulfill committee obligation
  - Discussed suspension of maintenance/cleaning party obligation during fall
    - Will advertise request for playground cleanup volunteers
    - Secretary will assign several people to maintenance committee
- Discussed extending deadline for families to withdraw without penalty to August 17<sup>th</sup>, allowing families to decide after trial virtual classes and info session are held
- Policies & member agreement addendum:
  - May enroll in virtual enrichment without enrolling in core package (no change)
  - Students enrolled in only virtual classes do not need to submit health and safety paperwork, but should fill out the emergency form.
    - Students without health and safety paperwork cannot be without parents on school grounds
  - No parent medical form required due to no co-op
  - o Outdoor classes will not be refunded if canceled for weather
  - o Outdoor classes may be suspended due to local health conditions by vote of the board
  - Enrolled families get one vote per student (no change)
  - o 30 day notice for withdrawal will be in effect after August deadline extension
- Start date
  - Reached consensus on September 14<sup>th</sup>
    - Outdoor class teacher needs Medical Administration Training (MAT) and CPR certifications, and MAT training is not available until Sept 11<sup>th</sup>
    - Teacher expressed concern about starting the same week as FCPS which is stressful for staff with older children
- Staff compensation CLOSED session

The meeting was adjourned at 10:30 PM.
